Upgrade & Update PartsLookup Software:

- Insert the new CD into the CD Drive
- 2 Click on "Proceed to Main Installation Menu"
- 3 Click on the appropriate "Ver X.XX Changes" button to see changes to the new version and new Training clips.
- Click on "Install PartsLookup and/or Vendor Price Files" 4
- 5 PartsLookup will automatically update any required files, and may reboot your system.
- 6 Continue with PartsLookup Installation following all instructions
- 7 Price files can be updated at this time.

Install New/Updated Vendor Price Files ONLY:

- Insert the CD into the CD Drive 1
- 2 3 4 When the first screen appears click on the EXIT button.
- With PartsLookup running, click on the UTIL button(F12)
- Click on Add/Delete Price Files button
- You may add, delete, or update only newer price files, as required
